Since XXXX Pub & Lounge in XXXX, reopened at XXXX, after having revamped their premises, I have endured excessive noise coming from the Pub's loud "Doef-Doef", techno, karaoke and rave-type music. This happens continuously, on a weekly basis, from Monday to Saturday between 18H00 and midnight. I am working, studying, have a sick child or studying, etc. They diagnosed me with chronic asthma in XXX. I cannot invite friends and family over for braai or visits. The situation is becoming detrimental to my health, both physical, emotional and psychological. To endure four to five hours of loud "Doef-Doef" music every week for 6 nights in a row is too much and not normal for a reasonable person.

I have phoned and complained frequently since the beginning of October 2020 to the SAPS and Municipal Police, with no success in resolving the Noise Nuisance caused by Chicago Pub & Lounge. E-mails (Annexure A) and Monitoring Forms (Annexure B) submitted as proof. I'm not the only resident that is being affected by this noise nuisance.
